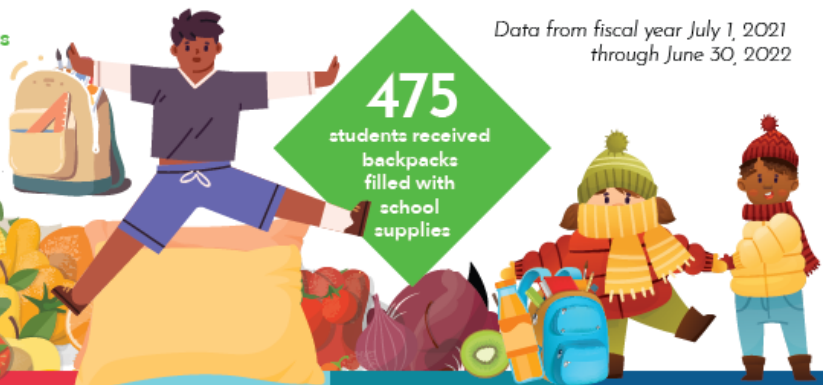
**\$1 donated = \$3 worth of food & basic living essentials**
