

Our Programs

Despite ongoing economic challenges, Neighbor to Neighbor remains committed to providing fresh, healthy food. We experienced consistently high demand across all our programs, with a noticeable rise in first-time visitors. Meeting this continued level of need depends on a reliable flow of food into our pantry — sourced through in-kind donations, retail rescue efforts, supplemental purchases, and generous community support.

FOOD ASSISTANCE

Supplemental Food Program: Greenwich residents who meet income guidelines may receive three days' worth of food for each member of the family each week. Neighbor to Neighbor also offers a home delivery service for those who qualify.

Summer Supplement Program: School-aged students whose families qualify receive additional breakfast and lunch foods during the summer.

Emergency Food Program: One-time emergency food is available to anyone in immediate need. We refer them to the appropriate support resources.

CLOTHING & ESSENTIALS ASSISTANCE

Clothing & Essentials Room: On a monthly basis, we provide personal care products, household cleaning items, feminine hygiene products, new clothing to our clients, along with new linens of sheets, towels and blankets each year. Effective August 1, we initiated a drive for new and gently-used children's clothing that is also available to clients monthly.

School Backpack Program: We distributed new backpacks filled with school supplies and water bottles for the new school year.

Coat Program: We provided cozy, hooded winter coats to children across our community for the winter season.


